PRID'S FAIR PROGRAM

On July 9, 1965 the Ford Division was host to our Ford Authorized Reconditioners for cocktails and a buffet luncheon at the Ford Pavilion. The charge, Number R-02641 in the amount of \$1,069, is well over the cost projected in discussions with Shirley Jamar prior to the luncheon. It is my view that this charge is considerably in excess of what it should be.

The attached correspondence to Mr. Dever and his reply of October 4 summarizes the situation as it now stands. I believe my letter presents an indisputable case in dispute of the amount of the liquor charge. I think it is equally clear that neither Mr. Pullen nor Mr. Dever have dealt with the questions raised in my letter.

May we have your assistance in getting this billing corrected or at least some justification of the billing beyond stating that according to Restaurants Associates records the billing is correct?

Dear Mr. Johnson:

Enclosed you will please find Rotary Club check to your order in the amount of \$603.00 in complete payment of reservation No. 03266 for the dinner at the World's Fair on Sept. 9, 1965.

The reason for this delay in reimbursing you for our dinner has been due to the fact that several of our members were adamant in their opinion they were gouged and refused to pay their share.

An examination of the invoice discloses that there were 29 dinners served to our members, some of whom did neither smoke nor drink. It was the consensus of opinion that we did not consume 69 cocktails (\$86.25) nor did we consume 63 glasses of wine (9 quarts \$99.00), nor did we consume 47 cordials (\$82.25).

It was the consensus of opinion that the dinner was superb, in fact really marvelous. We were so overjoyed with the dinner that we took a pool to see how many of us were Ford owners and I personally phoned Miss Shirley Jamar at the Ford Pavilion to notify her that we as a small group owned 20 Fords and one Lincoln Continental.

Each member who attended was required to pay \$44.00 for himself and his wife or \$22.00 per person. We feel that this is exorbitant and that we could not have consumed the amount of alcohol for which we were charged, and feel it should be brought to your attention so that you can investigate otherwise, we feel it was poor public relations on the part of the Ford Motor Company to permit this.

We believe that the persons who served the dinner may have confiscated for their own use some of the liquor for which we were charged.
