Jim Cassin and I have been receiving a number of inquiries from the World's Dear Walt: Pair Corporation, State officials, and our local press in regard to possible modifications of our Lincoln show at the Illinois Pavilion. It will be helpful to my Commission to have a better idea of what you have in mind for 1965.

It would be particularly essential for us to have some ammunition in terms of the Disney production improvements and additions when we present the Legislature with our request for additional funds, including your 1965 fee of \$250,000.

Specifically, I would like to call to your attention the widespread impression that Lincoln will eventually deliver other speeches at the Illinois Pavilion and that the animation will be brought to the standard of perfection which you described

in our most successful Springfield converences last year. I know that you have been kept informed of the response to your shows at the

Illinois Pavilion and once again let me express the appreciation of the Commission for your continuing assistance. I am perfectly aware of your personal interest in this as reflected in the help provided to the Pavilion management by your technical, crowd control, and merchandising staffs. I trust that your appreciate that we have financial limitations and I only wish that we could compensate you for the extra costs which you have faced, just as we have.
